Outreach

Reimbursement Benefit

Your membership in Rocky Mountain Health Network includes an outreach reimbursement program. Every April, the RMHN Board of Directors reviews the outreach reimbursement requests and approves them for the subsequent 12 months. If you are currently approved for reimbursement and want to continue receiving reimbursement for providing outreach clinics, or if you want to request approval for accessing your reimbursement benefit for a new outreach clinic, please send your documentation to Cheryl Ross cross@rmhn.org no later than March 17th. This will give us time to review and prepare the requests prior to the April 4th board meeting.

A copy of the current policy can be obtained by emailing a request to Cheryl Ross at cross@rmhn.org. All required documentation must be received for the review in order to be considered by the RMHN Board.

Micros and MACRA (from Carol Beam)

Thanks to all of you who made this year's annual meeting a great success (despite the blizzard that was going on). I would also like to thank Nathan Bays for sharing his expertise with everyone - MACRA is complicated and he did a great job of distilling the information to make it meaningful and actionable. You will also find detailed information on the quality scores for the MSSP for the past couple of years. This is important because participating in an MSSP helps providers with the MIPS scoring, particularly the quality component of MIPS. And we know that quality will have the most weight of the 4 categories for the next several years.

Please remember that you all have a standing invitation to learn more about the ACO and the MSSP. This invitation also includes MACRA and MIPS topics. I am available to come to your office whenever it works for you. We can go over the advantages of participating in the MSSP especially now that MIPS is upon us.

And let us know if you would like a copy of the annual report that was distributed at the annual meeting. We'll make sure you get one. Thank you all for supporting your PHO.
