ACO 2016 Quality Reporting

The annual ACO 2016 performance year Quality Reporting began on January 17, 2017, and will run to March 17, 2017. This is the time of year when Rocky Mountain Accountable Health Network (RMAHN) submits the findings of 17 quality metrics that are part of the overall quality reporting process for the Medicare Shared Savings Plan. The other 14 metrics are compiled by Medicare using claims data or are gathered from a patient satisfaction survey that we are required to conduct each year.

If you participated in the Medicare Shared Savings Plan for 2016, this quality reporting process we are undertaking will satisfy your PQRS reporting requirements. Good News!!!

Beginning in 2017, when MACRA kicks in, participating in the Medicare Shared Savings Plan with RMAHN will benefit your practice under the new reporting requirements for MIPS (Merit Incentive Payment System). Be sure to attend the annual meeting on February 7th to learn more about the role RMAHN can play in satisfying some of your new reporting requirements.
